

LOCAL GAYS ADVISED TO BE POLITICALLY ACTIVE

TUCSON - City Councilman Thomas J. Volgy and other local officials spoke at the Fineline on Monday, June 25 at a political forum sponsored by the Tucson Lesbian and Gay Pride Committee. Volgy spoke on, what he termed, "a silent issue".

The silent issue was Gay rights and, specifically, discrimination against Gays based on their sexual preferences. The issue is silent because that kind of discrimination is usually not contested by its victim.

Volgy reminded the group that he has been a long-time supporter of equal rights, and he urged the group to use the City Council to make their needs apparent to others.

In the seven years he has been on the council,

Volgy said there had been "virtually no contact" between the council and the Gay and Lesbian community. The issue of discrimination in employment or housing will not be solved unless people from the Gay community are willing to be open about themselves as well as their needs, he said.

"This issue has never emerged publicly on the council," Volgy told the group. "I believe the council is sensitive enough to believe it is a civil rights issue." Unless people discuss the issue, no changes will be made, he said. Volgy also encouraged the group to become as cohesive as possible and to challenge public officials by making them aware of issues of interest to members of the Gay community.

While the city of

Tucson has a human rights ordinance that prohibits discrimination on the basis of sexual preference, the county does not, said Vertie Sparks. Sparks is an affirmative action officer with the County Department of Employee Services. Although the county cannot discriminate on the basis of race, color, religion, ancestry, gender, age, physical handicap, national origin, or marital status, it can discriminate on the basis of sexual preference, she said. To correct the situation, Sparks encouraged the group to get organized and support candidates that are sensitive to their needs.

"What you are doing tonight is a step in the right direction," she said. She also suggested they ex-

pand the forum to include officials who are running for re-election on the County Board of Supervisors.

Jesse Borboa, an investigator for the Tucson Human Relations Commission, said he would be available to members of the group who feel they have been discriminated against, although he added that it is hard to prove someone did not get a job or was fired from a job because of his or her sexual preference.

Kim Hunter, an openly Gay delegate to the Democratic National Convention, urged members of the group to go public, to run for political office and to selectively vote for candidates who are sensitive to Gay issues.

This was due in no small part, to the efforts of the Tucson Lesbian and Gay Pride Committee who spent many hours in planning the weeklong activities and sponsored the fundraisers which enabled the Committee to produce the successful events. The TLGPC is to be commended for their total effort in these endeavors.

Pride Week got off to a big start at the annual Picnic in Himmel Park. Over 1,200 people attended this years celebration and

consumed 16 kegs of beer, and many cases of soft drinks. Between 60 and 70 people were registered to vote at the picnic. Bob Bishop, Jr. of the Joshua Tree and their DJ Guy provided music throughout the afternoon. A live women's band also played to the delight of the afternoon crowd.

On Monday, 60 people attended the Political Forum at the Fineline where city councilman and vice Mayor Tom Volgy spoke. (See separate story this issue). Also appearing were Jesse Barboa, the city's investigator of human rights complaints and Vertie Sparks, affirmative

action officer for Pima County. Kim Hunter, who was elected as the first openly Gay delegate from Arizona to the Democratic National Convention last month, also spoke to the group.

On Tuesday, approximately 150 people were on hand to watch the Dance Contest at Tramps. 9 couples were in the contest. On Wednesday, 225 people showed up at Rollers for an evening of roller skating with no injuries reported. On Thursday 78 people enjoyed the movie "Suddenly Last Summer" at Colette's West.

Only 32 people showed up for the free bus ride to

Gates Pass for Inspiration Night. Perhaps the rain or threats of rain scared many but from reports of those who attended, it was a beautiful sunset and a beautiful event. More than 50 persons attended the day long workshops held on Saturday at the MCC Church building. The workshops were rebroadcast on KXCI Community radio on Sunday, July 1.

A great week, one that will be long remembered by the hundreds who participated. Thanks to all those businesses, individuals and organizations who helped TLGPC in making Lesbian and Gay Pride Week '84 the huge success that it was.

A PAPER WHOSE TIME HAS COME

It all started way back in 1977 when the first issue of the TGN (Tucson Gay News) rolled off the presses. At the time there was no regular weekly paper in the entire State of Arizona. Needless to say the new venture took off like the wind. The first issue was on an 8 1/2 x 11 piece of paper, printed on one side only. The next issue was both sides, then two more pages then twelve and so on. The decision was made to go to tabloid size, increase the readership to include Phoenix and the Arizona Gay News was born. Lasting over six years and imparting thousands of words of "wisdom" throughout the Gay communities of Arizona, the AGN was one of five weekly Gay papers in the entire country. Beset by financial losses the AGN was put to rest in early 1983.

In March of 1983 some Phoenix investors saw the need for an opposition paper and The New Paper was born and continued to publish on a weekly basis until taken over by The Attitude in July of that year. Again beset by financial difficulties The Attitude continued until three weeks ago when the towel was thrown in. All three papers were good ones and I was proud to have helped in their success. By the way, success is not necessarily measured in money, but unfortunately the printers, typesetters, utilities, and the myriad of other collectors do not see it that way.

Getting off to a sound financial base is of the utmost importance in the establishment of a newspaper such as this. When the issue as to whether or not Tucson could support a paper of its own, I was assured by every Gay business establishment in this area that they would back the paper with whatever means possible to ensure the weekly publication of a Tucson oriented newspaper aimed at the Tucson Gay and Lesbian community.

NGTF SURVEY INDICATES WIDESPREAD ANTI-GAY/LESBIAN VIOLENCE

NEW YORK, NY - Violence against Lesbians and Gay men is widespread in America, according to a survey released today by the National Gay Task Force. Results of the study, which was conducted in cooperation with local Gay/Lesbian organizations in eight U.S. cities in June and July 1983, show that of nearly 2,100 Lesbian and Gay people surveyed, more than 90% said they experienced some type of victimization because of their sexual orientation.

The release of the NGTF Violence Project survey results came several days before the Democratic Convention which is expected to approve a platform pledging to "Address, document and end" violence directed against "women, ethnic, racial and religious minorities and Gay men and Lesbians."


"This study confirms in plain numbers what many in our community have long understood," said NGTF Executive Director Virginia Apuzzo. "To be Gay or Lesbian in America is to live in the shadow of violence."

Among the highlights of the NGTF report were: 1. Greater than one in five males and nearly one in ten females said they had been punched, hit, kicked or beaten because they are Gay or Lesbian, and approximately the same ratios had suffered some form of police abuse. 2. Approximately one-third of respondents stated they had been verbally abused by relatives because of their sexual orientation, and more than seven percent reported having been physically abused as well. 3. One fifth of the females and nearly half of the males surveyed said they had been harassed, threatened or physically attacked in high school or junior high school because they were perceived to be Lesbian or Gay. 4. Almost


half of the males surveyed and more than one-third of the females had been threatened with physical violence because of their sexual orientation. 5. Almost one-quarter of respondents said they had objects thrown at them because they are Lesbian or Gay, and more than a third had been chased or followed. 6. More than 90 percent of the males and 75 percent of the females had been verbally harassed because of their sexual orientation.

Anti-Gay/Lesbian violence clearly affects the attitudes and behavior of those surveyed: more than four in five respondents said they believe they might be victimized at some time in the future because of their sexual orientation, and most (64%) agreed that anti-Gay/Lesbian violence is prevalent enough to cause them to fear for their safety. Forty-eight percent said that they have modified their behavior because of anti-Gay/Lesbian violence.

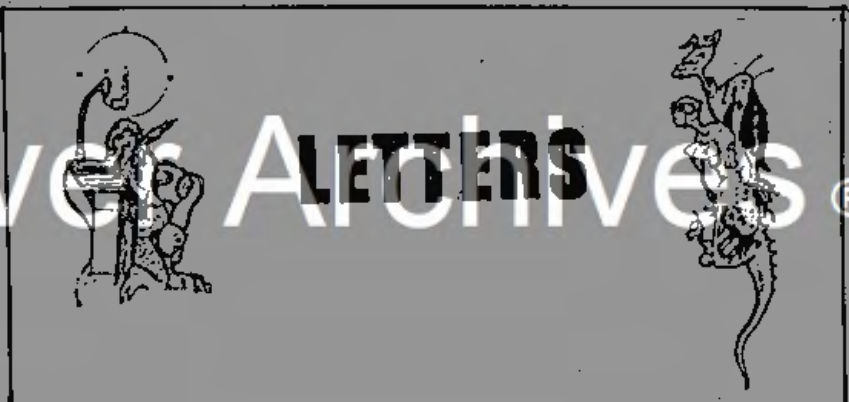
NEW COUNSELING GROUP FORMS

TUCSON - Dan Overbeck, Ph.D., Developmental Psychologist with the Center for Human Development in Tucson, will begin a men's counseling group in early August, 1984. The counseling group will be limited to a maximum of six men who present a range of persistent concerns regarding self-identity and self-worth, coming out, relationship difficulties, personal adequacy or other issues of a Gay or bisexual orientation. Meeting times for the group will be scheduled, as much as possible, to the convenience of the participants. Participants may be self-referred or be referred by their individual counselors or therapists.

The Center for Human Development's counseling group will differ from the on-going support group in that the men participating in the counseling group will typically express more

persistent and disruptive concerns. The emphasis of the group will be providing a safe, nurturant emotional setting wherein each man can openly and fully examine the recurring disruptive themes in his life, identify reasonable alternatives to resolve the problems and obtain the personal, emotional support needed while different alternatives are tested in real life settings. Although the group will not focus on changing orientations, per se, the group will provide a healthy, accepting environment within which a participant may examine their desire to change, and the implications of any attempts made toward changing to a more heterosexual orientation.

UNITARIANS OK GAY MARRIAGE

NEW YORK, NY - By an overwhelming vote, delegates to the Unitarian Universalist Fellowship's General Assembly sanctioned marriages between Lesbian and Gay couples. The Unitarians' action was the first of its kind by a major religious group in the country.

Unitarians have been consistent supporters of Lesbian and Gay rights. In 1970, the church endorsed civil rights for Gays and Lesbians, and in 1980 voted to support congregations who call Gay and Lesbian ministers. About six Unitarian clergy are openly Gay.

"This is a human rights issue in the sense of affirming human beings, to acknowledge and affirm and celebrate their commitment together," according to the Rev. Robert Wheatley, director of the Unitarians' Office of Gay and Lesbian Concerns. Wheatley has conducted about 40 ceremonies for Gay and Lesbian couples.

NGRA DEFENDS TEACHER VICTORY IN U.S. SUPREME COURT

SAN FRANCISCO, CA - The state of Oklahoma is asking the U.S. Supreme Court to reinstate its anti-Gay teacher statute. The law, which prohibits discussion of homosexuality by school teachers, was declared unconstitutional earlier this year by the U.S. Court of Appeals for the Tenth Circuit. That decision seemed to signal an end to a five year legal challenge mounted by National Gay Rights Advocates (NGRA), the San Francisco-based public interest law firm. However, the Oklahoma legislature then voted by an overwhelming margin to take the case to the Supreme Court.

NGRA will be submitting its reply brief this week. Leonard Graff, NGRA Legal Director, said, "We are asking the Court to affirm the appellate decision. It was a sound, well reasoned ruling based on established First Amendment principles."

Jean O'Leary, NGRA Executive Director, said, "The obvious purpose of this homophobic law was to eliminate Gay teachers. NGRA's commitment to defending out right to work and to speak out on Gay issues will surely be vindicated in the Supreme Court."

The Supreme Court can simply affirm the appellate decision or it can grant a full review. This would entail additional briefing and oral arguments. Since the Court is now in its summer recess, a decision will not be made until the first week in October.

U.S. MAYORS CONFERENCE ENDORSES GAY/LESBIAN RIGHTS

PHILADELPHIA, PA - The U.S. Conference of Mayors endorsed a resolution recommending "that all levels of government adopt legal protections for the rights of Gay and Lesbian Americans," at their annual meeting here. Commenting on the passage of the resolution National Gay Task Force Executive Director Virginia Apuzzo said, "This is explicit recognition that discrimination based on sexual orientation is a reality in the everyday lives of Gay and Lesbian Americans. It also places legislative and executive efforts to remedy this problem squarely within the general civil rights agenda."

The Conference is the first organization of elected officials to take a position in favor of Gay and Lesbian civil rights. The resolution addressed discrimination in employment, housing, and the criminal and civil justice systems, as well as government policies excluding Gay and Lesbians from military service and immigrating to the United States.

The issue was first considered by the Conference's Committee on Human Development during a presentation by Apuzzo in Washington, DC in January. The resolution's sponsors - Arthur J. Holland of Trenton, NJ; Thomas H. Cook of East Orange, NJ and Marion S. Barry of Washington, DC - all argued for passage during a Resolutions Committee debate. Cook said it was "incumbent (upon) enlightened public officials" to provide equal opportunity for all citizens. Mayor Holland suggested that specific protections were needed because Gay and Lesbian rights were not implicit in the Constitution. Barry reminded his colleagues that no matter how small their city, they had Gay and Lesbian constituents who needed legal protection.

More than fifty state and local jurisdictions in the United States already have legal protections against discrimination based on sexual orientation. "Today's action," NGTF's Apuzzo said, "will be a major impetus for a push by local groups to expand that list."

NGTF Washington Representative Jeff Levi, who was present at the conference, added "The action by the mayors is a response to the growing realization that for civil rights protections to be meaningful they must be applied to all minorities in society without exception."

COMING OUT TO YOUR PARENTS

PHILADELPHIA, PA - "Coming Out To Your Parents" is a 16-page booklet published for Gay men and Lesbians who are considering coming out to their parents. The booklet, published by Philadelphia Parents of Gays (POG), identifies six stages most parents go through when they learn of their Gay child's sexual orientation.

The six stages of understanding (shock, denial, guilt, anger, personal decision making and true acceptance) are described, along with specific ways young adults can assist their parents in each of these stages. The author, the father of a Gay son, identifies the stages on his personal experience and hundreds of other parents who have attended Philadelphia POG.

A list of over 100 parent groups/contacts in 47 states is provided. These parent groups are members of the Federation of Parents and Friends of Lesbians and Gays (Parents Flag), whose headquarters is in Los Angeles.

The booklet was published to use at Philadelphia POG's November 18, 1984 "Coming Out To Your Parents Workshop". This annual workshop is conducted by POG because they want to assist young adults in considering coming out to their parents and to enable them to do so in a manner that is helpful and productive to the family. "We considered how we could strengthen the family during this usually stressful time," said POG President, Tom Sauerman. "As parents who know first-hand the full range of emotions and responses, we felt we can guide young people even before the moment of disclosure to their parents."

Bed(ding) By The Bay

SAN FRANCISCO, CA - Bed-By-The-Bay is a bed and breakfast agency which places visitors to San Francisco in private Gay or Lesbian homes, apartments and condominiums. It has become a vital part of Gay San Francisco. The service is a unique concept of the long-accepted bed-and-breakfast tradition that, for years, has been popular throughout Europe, and which is gaining fast acceptance in this country.

Acclaimed as the first of its Gay kind in the United States, Bed-By-The-Bay was founded in 1981 by Don Stanke and Patt Shea. "Since then," says Don, "we have acquired more than 55 host accommodations in San Francisco and Marin County. We have placed more than 100 guests. Some of our homes are authentic Victorian and Edwardian landmarks. For those who don't care about folklore, we have contemporary accommodations in first-class condominiums and homes with views, sun decks and patios." Stanke continues, "All of our Gay hosts and hostesses express one wish: That their guests should feel at home. They do everything possible to accomplish that goal such as tips regarding restaurants, baths, bars, etc. Bed-By-The-Bay's start at \$19 per day for single occupancy. LESBIAN & GAY ASSOCIATED ENGINEERS AND SCIENTISTS ANTI-GAY ALERT!

One of the methods used by anti-Gay psychiatrists to invasively determine sexual orientation in conjunction with aversion treatments is the Electroencephalogram (EEG). This apparatus up to now had limitations. It had to be attached to the head with electrodes using conductive pastes and it primarily measured the electrical activity at the surface and near the surface areas of the brain.

Recently, as reported in the McGraw Hill magazine "Electronics", November 1982, a new method of measurement of brain activity called the Magnetoencephalogram (MEG) has been developed using superconducting Quantum Interference Devices (SQUIDS). This device can not only measure the electrical activity within the brain that was previously only accessible through surgical implantation of electrodes, but it can also do it without physical contact with the subject. Additionally, the device can characterize other parameters that the EEG could not measure.

Though primarily designed to aid epileptics, its interest to Anti-Gay psychiatrists is virtually assured. Every technical advance that measures any neurological function has been used by anti-Gay psychiatrists to detect homosexuals that might be trying to evade detection and to monitor the effects of aversion therapy, both drug-shock and electroshock.

The equipment has been miniaturized from cumbersome large apparatus to a small portable unit. Formerly the apparatus had to be strapped to the sub-

The Lesbian and Gay Associated Engineers and Scientists (LGAES) urges all Gays and Lesbians not to participate in any experiments using Magnetoencephalograms in sexual orientation measurements. If in doubt please feel free to contact LGAES who will be more than willing to investigate the matter. Also LGAES is interested in any anti-Gay research of this kind and would appreciate reports of any such research.

- The following is the LGAES guide for detecting or avoiding anti-Gay research:
1. Do not participate in any experiment in which a penile plethysmograph is attached to you. This is a device to measure the extend of an erection in the male. The date could be used to evaluate the accuracy and effectiveness of some new device or machine.
 2. If films, photos, or sounds of an erotic nature are shown, do not participate. Measurements of your heartbeat, pupillar response, or galvanic skin response could be used to invasively detect Gays.
 3. Investigate the researcher. Determine if any anti-Gay studies have been published. Your medical library, Gay Student group or LGAES could provide information to help.
 4. Notify your local Gay organizations, LGAES, and local Gay paper if any anti-Gay research is detected.
 5. Discourage any non-Gay friends from participating. Straight people are used as the control in the studies. If the researcher is a professor at a university, warn his students so that he cannot draw his controls from his students.

TUCSON SUPPORT GROUP

TUCSON - The Tucson-based Center for Human Development is scheduling another five-week Men's Support Group beginning this month. The program is not a counseling or therapy group, but rather an opportunity for married Gay men to explore the issues that are central to healthy adjustment and optimum personal functioning. The format of the series includes a weekly meeting of approximately two hours; each of the five meetings focuses on a specific issue for discussion and is followed by an opportunity for the participating men to share their ideas, feelings, needs and suggestions regarding the week's topic. No formal presentations are planned. An informal rap will be available following each two-hour meeting for those men who wish to continue the relationship-building, and the group may continue beyond the planned five-weeks if the participants wish.

The support group operates on the premise that each man's marital and Gay status is a highly individual and unique matter. As such, each man must decide whether he wishes to work toward sustaining and strengthening the marital relationship or instead to move toward dissolution of the marriage; whether to come out to his wife (and/or family) or to keep his homosexual interests and activities covert; whether he will be open to, or insulated from, the possibilities of an emotional, affectional relationship with another man and the implications of that decision; how he can best cope with the feelings of resentment, confinement, guilt, ambivalence, etc. that can occur as he tries to express his full sexual and emotional self and still maintain the expected marital role; and how he will cope with the desire for Gay sexual outlets and the inter-personal and health issues that can arise.

During the five weeks, the participating married Gay will have a positive,

self-enhancing opportunity to explore and examine his values, beliefs, sexuality and capacity for personal intimacy. All matters relating to the group are discreetly managed and confidentiality is assured.

Although the Men's Support Group is limited to approximately six men each session, two concurrent groups are planned. The only eligibility requirements are that the participant must be (1) Gay or bisexual and (2) planning marriage, currently married or recently divorced. There is space available for two more men; any married Gay who is interested in the remaining openings may contact Dr. Dan Overbeck's office, himself a formerly married Gay psychologist, at 884-0476 for additional details. Meeting dates and times will be scheduled once the participant roster is full, and will, as much as possible, be at the convenience of the participants.

GAY SITCOM ON CABLE

HOLLYWOOD, CA - "Brothers," a weekly, openly Gay situation comedy is now being taped for cable pay station "Showtime," after NBC declined because the show was deemed "too advanced" for network airing. "Showtime" placed an order for seven episodes, with an option for six more. According to producer Gary Nardino, "Brothers" will involve the "ongoing story of how two conservative brothers in a blue collar family treat a younger brother who suddenly scraps his wedding plans and informs his family that he is a homosexual.

The episodes will be shot on the old "Laverne and Shirley" set using a three-camera technique, making a live audience a possibility. Nardino called the show a "groundbreaker, much the same way 'All In The Family' was in its time." It will "deal with the issues frankly but with humor and honesty. We hope to present a very clear and open view of the homosexual lifestyle.

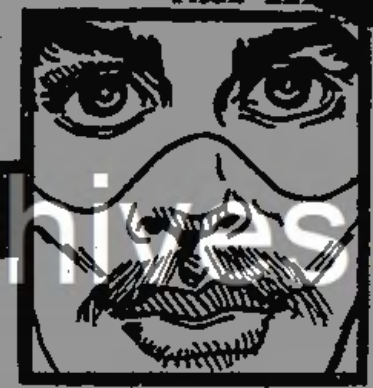
UNITED SUED BY GAY MAN

LOS ANGELES, CA - United Airlines is the target of a suit filed in Los Angeles by a Gay flight attendant who claims he was in effect fired because he has AIDS. In his suit, Gar Mitchel Traynor, who had worked for the airline since 1973, was put on permanent "medical leave without compensation" after he told United of his disease in late 1982.

Traynor claims that United publicly acknowledged that having AIDS posed no health threat.

to the public or his co-workers. Nevertheless, the airline did not give Traynor a chance to continue his work or transfer to another job.

Traynor's suit is especially relevant since job discrimination poses a double bind for people with AIDS. At the time they face enormous medical expenses, they are also threatened with loss of employment and health care benefits.

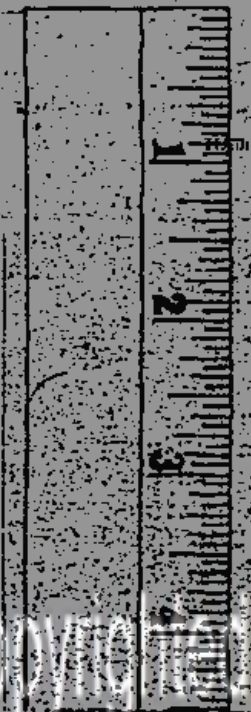
